***Previous to 1977 supplementary regulations**

For machines 1976 and older & any 1977 models that have the same specifications as 1976 version.

Rear suspension, for machines designed to have more than 4 inches rear suspension travel up to a maximum of 8 inches

Front suspension, Maximum travel 8.5 inches original diameter fork tubes.

Reed valves, aftermarket reed valves may be fitted
