AROUND THE CENTRE

It never ceases to amaze me just how much money sponsors are prepared to invest in a single seater motor racing car especially when one realises just how little the projectile is used for the purpose of traversing tarmacadam guickly and how much time it spends testing the strength of an armco Carrier. It is therefore understandable that some such people should look to a less destructive form of spending money, and I suppose obvious, that sooner or later the world of moto crash will be on the receiving end. There is every sign that things are already on the move, for during the winter lay-off the amount of interest focussed on the sidecar re-building programme has been enormous. Any worries about the Robbie Rhindd Tutt Meal Ticket Fund were soon dispelled with the news of Westlake, B.M.W. and Norton all anxious to reap a successful summer harvest. Normally of course I would have mentioned Triumph, but as there seems to be a company policy to prevent machines leaving the factory, we must presume that the existing production is being retained for the vintage market. The solo division too is subject to more than its usual share of limelight; I suppose more pronounced by the larger than usual change camp and contract process. Certainly this year seems to be far more wide open in respect of national honours and let us hope this centre is well represented, for the Mick Jones's and Les Lloydd's seem to be making good progress up the ranks, so let us wish them well.

Now most of you will have heard of the 'Three Musketeers' those dashing swordsmen of yesteryear, then there is the 'Three Horseshoes', a pub up the road a bit, so may I introduce the 'Three Geoffs', the Southern Centre Premier Award stealers. I mean of course Geoff Chandler, Geoff Monk and Geoff Guy who between them have excluded all others from major honours, except in odd cases where Sam came home from his feet up scramble demonstrations. Chucks of course has joined the selective band of professionals seeking fame and glory in the world trick cyclist series, and in finishing fifth in the Irish round certainly established his share. Then of course he came home to the Broadchalke event and, when the rest of us would have been better off with toboggans, notched the No. 1 spot for good measure. Monkey started his run at Bishops Waltham with a ride so fantastic that I doubt very much whether anyone about at present could have bettered him. Not that he stopped there, no he has more than justified the Hossah man's award. Gee Gee, he's the short podgy one of the two, is

another blessed with support by the, ex Leeds, Bournemouth-based concern. Since that time he has never been lower than third, and at Bridport was right behind S.H.M. some Hirish Man, and a mile in front of the rest. Very flash, might even match Dorman's smile when he gets the bottom row.

With the general resumption of normal on off road trials, it is only natural that this should come at the end of the season. So for the third time in five years we have suffered disruption in the winter months. If ever there was a good reason for taking up the cloth, then surely this sport must take the huntley and palmers. Any normal young healthy fellow went about his normal winter sport, that of hell bent crumpet chasing, absolutely unhindered, so why the second best sport in the land must keep suffering can only be considered offside. We have read a great deal about the big K man's hopes for the select band of pros and his views on where the sport will end. I think it's fair comment to say the sport is going nowhere and whether these super stars can attract their own paying gate or be obliged to join forces with Billy Smart is something we care little about. Meantime of course the home national scene is suffering considerably with this pro-am state of affairs. Competitors, not wishing to compete for the wreck of the day award, are no longer supporting the big events and subsequently entries are dropping into numbers that make organisation difficult. No doubt this financial injection by Rocol, I think it is, will help clubs to run the national series which is a lot better than seeing it die completely. As I scored a direct hit on the waste bin some weeks back with the regs of this year's Scottish, I did hesitate to get the gist of them and remember back to when it was subject to full trade support and other than entry fee and digs, everything was on the house for everyone. My, haven't they done well over the years? Frightened of making the event subject to qualification and accept some outside help on a par with the push bike milkrace, they allow the privateer to sponsor the event on some sporting pretext, and make about as much allowance for them in the event as Geronimo did for Custer. True, there is a lot of sport to be had in Fort William that week, but it has nothing to do on motorcycling.

It is amazing where the comic editors dig up their reporters these days, judging by some of the rubbish that has graced their pages recently. Headlines in front of me as I write this are quote 'Riders outvote bid to Cancel M-X Meeting.' It was of course concerning the Newbury event at the Fox and Hounds put in jeopardy by overnight snow. Ignoring the possibility of losing money, are we really meant to believe that a pack of loud hailers overruled the official organisation. Not at any stage does the writer give cause for alarm to the landowner's property, nor is there a mention of the riders offering to accept reduced prizemoney. The report went on to say that because one particular outfit broke down, the absence of their wild style made the event a hard slog. Personally I would have thought John Turner and the rest put on a pretty good show, and were probably glad not to have anyone going at right angles to the course. The old idea of reporting a race seems to have vanished, that is to say a precis of how the race was won, and instead we end up with twenty per cent fact and eighty per cent drivel. Never once in that particular report was there an instance of the first six at any given point of any race, but then as I have said before these writers have no idea how much ability it takes to ride in such conditions, let alone be in the first six.

BOARD COMMENTARY

Mr. J. Caslake, the Centre President, opened the third meeting of the Board at Southampton M.C.C. Clubroom on 7th March. Apologies were received, the previous meeting's Minutes were signed by the President as a true record, following one correction.

The Chairman, Mr. Roy Brett, then took over for the remainder of the meeting.

The Roll Call revealed 14 Officers and 52 Delegates representing 24 clubs were present.

The By-ways Trophy was presented to Tony Jeffreys by Mr. Caslake, we then got down to business.

The Secretary asked clubs to return the questionnaires sent by the A.C.U. regarding Fuel Economy to him soonest. The Entry Levy cards would soon be sent to clubs, these should be returned with the 3% levy cards within seven days.

Mr. Ken Gale reported on the General Council Meeting, after discussion it was decided that the ruling regarding "cut-outs" for Grass Track sidecar outfits will take effect immediately (note GT Regulations).

Mrs. Steel read the Minutes of the Competitions Committee meeting held on 18th February. Mr. Allen proposed the Minutes be received, Mr. Mould seconded and all approved. The Board approved the Scrutineers committee. Mr. Lambert then explained the duties of a measurer.

The Centre Executive Committee meeting held on the 5th March 1974, Mr. N. Goss reporting said that the meeting was called to discuss the situation arising from a court of inquiry being called and not being proceeded with. This was due to irregularities in procedure which may have involved the organising club of the event in question. Further information from that club had been asked for and this would be discussed at the next Competition Committee meeting, it is hoped all Centre Stewards will attend as the outcome of the discussion could have an important effect on their future procedures.

The Committee then discussed the juridical panel which still exists, it was agreed that there be a list of members up to 10, this number being made up to strength by new nominations. Future Centre Courts would then be drawn from this panel.

Affiliation Fees. Bourne Club, having still not paid, all approved Mr. Moulds proposal the club should be given 14 days; if not received by then, they should be struck off. This ruling also applies to Southern 67.

The Dinner/Dance is now going ahead, arrangements are completed to hold the event at Top Rank, Reading on 4th October 1974. The price for tickets is fixed at £2.80. Mr. Nash asked for raffle prizes, he will be pleased to accept anything, even money!!!

The Sub-Committee for the Inter-Centre Team Trial have appointed Mr. D. Kingswell as the third member. Mr. Bowley, in his report, said that an estimate on expenses likely to be incurred would be submitted to the Board.

The Centre Gazette. Mr. C. Holdstock apologised for the lateness of the March edition, due entirely to the three day week. He reminded all that he still required a volunteer for the Board Commentary.

Start: 2.00 p.m.

Mr. D. Kingswell reporting on Rights of Way said there had been some storm damage to a Green Lane; he would see this was cleared. Roy Brett said he had sworn an affidavit on the matter of the U33: this would incur some expenses.

The Benevolent Fund Officer, Mr. H. Bone, reported receiving donations from P.M.C.R.C. and Salisbury Clubs.

Treasurer's Report. Accounts for payment were presented, it was agreed these should be paid.

It was proposed that the Centre accounts should be discussed by the Special Finance Committee. Mr. Lambert raised the question that matters normally dealt with by the Committee were being passed by the board. The Chairman referred the matter to the Finance Committee for their comments.

A.O.B.

Mr. N. Ley drew attention to the fact that some riders under the age of 17 were seen on public roads when competing in Trials. He wished the entry forms to read: "Do you hold a current driving licence". However it was felt that Club Officials should make a more stringent check. But the onus was on the rider and his parents to make sure this did not occur, they are the ones to suffer in the event of an accident.

Mr. Ley also reported unauthorised practice is again taking place on W.D. land at Bovington. The Centre Secretary is to write to the Commanding Officer.

Mr. F. Page drew attention to the fact that some Trials riders were only displaying one number; he emphasised that two were essential if observers were to do their jobs. He also stated that too many riders and their followers were arguing with observers, this should be stopped. Clubs must enforce the Rules. (The threat of 5 usually has the desired result).

Alton Club asked about upgrading Schoolboys. It was agreed they should be subject to upgrading as other riders. Mrs. Lambert stated she was not getting copies of results. A provisional list of awards must be sent to the permit Secretary within three days of the event.

The next meeting will be held on 4th April 1974 at 8 p.m. at Southampton Clubroom, Eastleigh.

Meeting closed at 10.35 p.m.

3. Course: Grass Track circuit incorporating an 'S' bend, approximately 500 yards in length. Solos to run anti-clockwise - sidecars clockwise.




