By the time the first few following weeks have passed, all the loving fettling has been wrapped round some tree or fellow competitor, by way of showing that last year's super crashers are still super at it.

You may recall that last time I said we might see Les Lloyd's name in national honours lists this year and it was very pleasing to see that in the opening tiddler rounds at Hawkestone he obliged with two fine rides. Having done much of his riding at Bishopstoke and Brimpton, two of our more popular bumpy field courses, it was interesting to note that the Shropshire circuit held no terrors for Leslie, that is if one realises the difference between the venues mentioned. I suppose if we compare Ben Nevis with Butser Hill, one gets a clearer picture in terms of severity.

Hands up all of you who owned a C15. I wonder if they still all suffer the odd nightmare. Anyway, well done Vic Allan, keep it up, for this country of ours needs some good news.

BOARD COMMENTARY

We journeyed for the usual first Thursday of the month in the pleasant early evening air, wondering whether Board Meetings in June, July and August could not be held in the open air of some New Forest Inn's Beer Garden.

The Board met at the kind invitation of Southampton and District Motor Cycle Club at their Headquarters on 6th June, 1974. In the absence of Mr. Caslake, our President, who sent his apologies, the meeting was opened by Mr. George Hodges (so nice to see George in this position). Apologies were received from: N. Goss, K. Gale, J. Mould, C. Holdstock, A. Carpenter, A. Lambert and Mrs. V. Lambert.

The Secretary reported that our President had been seriously ill in hospital and was yet to come home, also that Peter Ryall had again taken a turn for the worse. Mr. A. Lambert had just re-started light duties at work that week.

The Minutes as circulated were approved and signed. Mr. Roy Brett, Chairman, then took the Chair for the remainder of the meeting.

Roger Broad, Centre Secretary, had written to the South Western Regional Sports Council drawing its attention to the anomaly of one delegate only representing Motor, Motor Cycle and Power Boat Sports, and we still await a reply.

- 8 Board Officers, 47 Delegates, representing 22 Clubs arose for the Roll Call.
- (a) Those enquiring and "nosy" types who like balance sheets can inspect Auto-Cycle Union Accounts, providing they are "registered" A.C.U. members.
- (b) The Southern leads again. LONDON, in its inevitable wisdom, has ordained that Centre Scrutineers Panel must operate as from 1st January, 1975. They have asked and received a report on your Centre Scrutineers Organisation. (We will see if they can operate it by January, 1975.)
 - (c) National Rally Entry Forms available from Roger Broad.
- (d) The Men in Blue Thames Valley Police Motor Club (South) have been "officially" affiliated.
- (e) Inter-Centre Grass Championship (to be organised by our own Blackmore Vale Motor Cycle Club on 25th August at MERE) regulations were passed to Centre Grass Track Sub-Committee.
- (f) Dear George Allen wrote thanking the Board for allowing him to represent the Centre at LONDON. Grass Track Committee (shame on them) did not co-opt him, but they did acclaim his past efforts.
- (g) The Sherborne Sports Council had asked and been sent a list of local Southern Centre Motor Cycle Clubs, but unfortunately Blackmore Vale Motor Cycle and South-Western Centre had been omitted. Roger Broad agreed to send an amended list.

Sunbeam Club applied for Graham Walker Memorial Run - 15th December - approved subject to no objections from Frome Valley and Winchester.

Gallant Salisbury have offered and been accepted to organise St. Paul's Trophy event on 29th September. Thank you, Salisbury.

Basingstoke, alias, Brian Maynard, has resurrected that "old potato" of standard regulations, referred to the next Competitions Committee Meeting.

Our Competitions Chairman has had his baptism of London Council, and therefore he was called upon to give a very comprehensive Council report, included was how impressed he was with amount of material the Council dealt with and also warning to naughty boys. Someone has been suspended for two years for unauthorised procedure.

The Chairman congratulated Mortimer and Mr. Challis (and Mrs.) for organising Centre Team Trial. For the gourmets Sam M. won Waterlooville 'A' Team First followed by Northants 'B'. While still on his feet Mr. Challis reported on Centre Scramble Championships - Organisation was O.K. 40 Maximum sidecar; Solos weak. Marshals urgently required to report at 10.30 a.m. please.

A Court of Enquiry had found Mr. Ralph guilty under G.C.R's and had been severely reprimanded with £5 costs (since paid).

The Brett "Hot Skip & Jump and nosh-up" has retarded ticket sales, but friend Nash would like some Raffle prizes. (A voice was heard asking if the Officer's Mess at WARMINSTER would be 1975 Venue).

The Scrutineer's Seminar held on the 19th May at Downton was not attended by all the applicants, due to date clashing with two major events in the Centre, to which applicants were already committed. All passed, with a few told to "swot up". Mr. & Mrs. Mike Lane were thanked for canteen, and all expenses to be paid by the Centre, of course. Mr. Ley suggested another Seminar, but NOT on a Sunday. This was O.K'd.

That man Holdstock again failed to report (I dare him to print this!), just to get rid of Board Commentary, which it would appear he has succeeded. O.K. Colin, we pushed you too hard, and thanks for standing in - Mr. Southern Gazette.

The X.H.G. Club, through Mr. Ley, had had its attention drawn by a Board Official, of two riders riding one and same machine. A warning will be published in the Centre Gazette reference this matter.

minutes of his number being called will be excluded from that race.

7. Entries: Will open on 7th July and close 15th July. To be made on correct entry form and sent with correct entry fee to Secretary of the Meeting. Solos £1.10. Sidecars £1.60. Stamped Addressed Envelope for reply. No late or incomplete entries will be accepted. The right is reserved to refuse an entry without explanation. The entry may be restricted at the organisers discretion. Preference will be given to

Speedway type machines. NO ACCEPTANCE PASS - NO FREE ENTRY.

Yellow Flags: In the event of any course obstruction all yellow flags will be shown around the course. Drivers will reduce speed and maintain position until flags are withdrawn. Any driver deliberately gaining an advantage while flags are out will be excluded. The Clerk of the Course shall exclude immediately any driver who, in his opinion, is guilty of any foul, unfair or dangerous driving. Should the Clerk of the Course decide to stop a race in the interests of safety, then that race will be re-run.

THE JOHN FISHER GRAND PRIX OF GREAT BRITAIN

I make no excuse of the fact that the next page or so is devoted entirely to this year's round of the 250 cc series organised on behalf of the A.C.U. by the Portsmouth Club for two very good reasons. One, it is the first time a world event has been organised in this centre and two, judging by some of the eyewash already written in various publications we should give praise to whom it is deserved and not some hairy fairy tale made up to fill the required number of words. Portsmouth as a club have been working over the past years on gradually building up their events to a point where their ability to undertake such a promotion was not the dreaded nightmare we might imagine. They took on the task of reviving what seemed a flagging show and presented to those there, a great spectacular in which even the most ardent knockers had a job to fault. Thanks to landowner Willie Budden, also known as the conqueror of steep trials hills, they laid out a real Grand Prix course which kept the crowd in touch of most of the three minute plus lap, and they came up with organisation of the highest order to go with it. The fact that the petty cash did not get in any way dented must revolve around the sponsorship of John Fisher and also the excellent P.R. work done before hand, though the series being at the midway stage did mean that the club were sure of a representative field of contenders for the injured Andersson's title. So there we were the scene set, the clouds kindly withholding their content and only the action to come. And some action it was too, for seldom have we seen racing as competitive as that witnessed. By lap nine of the first race our home runners were second, seventh, eleventh, thirteenth, fifteenth and seventeenth in the form of Vic Allan, Malcolm Davis, Rob Taylor, Terry Dyer, Stuart Nunn and Roger Harvey respectively and that meant four newcomers in Grand Prix racing were in the top half of the field, and that, in my book is trying. If I have been guilty in the past of rocking our grand prix performance-boat, then it was because we were not getting results. Time has changed that and we must reckon that Vic Allan is as quick as the next in world class ratings. Race two was a little disappointing with the loss of Allan & Co. but again the newcomers stuck to the task and more than justified their right to a start place.

The trade barons were there in the pits with some very expensive equipment; in fact one could have been forgiven for thinking that the whole scene has become one of wealth on a par with motor car racing. Perhaps it has. Anyway the whole deal at Chalton was definitely number one stuff and the Centre should feel proud that one of our club's went it alone and came out on top.

- 6. Starting: Clutch start by elastic tape or flag. Any rider not on the start line within 2 minutes of his number being called will be excluded from that race.
- 7. Entries: Will open on 7th July and close on 20th July. To be made on the correct form and sent with the correct fee to the Secretary of the Meeting, together with a S.A.E. No late or incomplete entries will be accepted. NO ACCEPTANCE PASS NO ENTRY. Solos £1.10 Sidecars £1.50
- 8. Yellow Flags: In the event of a course obstruction or accident, the yellow flag will be shown round the course and drivers will immediately reduce speed and maintain position until ALL flags are withdrawn. Drivers failing to comply with this regulation will be excluded from that race. In the event of a race being stopped the Clerk of the Course may decide to re-run that race.
