

The Chairman took over the meeting with matters arising. Clubs will have their permits withheld if the questionaire on fuel saving is not returned.

Bourne Club would not be affiliating, they will endeavour to settle all debts.

Roll Call and distribution of A.C.U. handbooks, there were 12 Officers, 19 Clubs represented by 43 delegates.

- 6. Starting: Clutch start by elastic gate or flag. Any rider not on the starting line within two minutes of his number being called will be excluded from the race.
- 7. Entries: Will open on 7th May and close 15th May. To be made on correct form and sent with correct fee to Secretary of the Meeting. Solos £1.10, sidecars £1.60. Stamped Addressed Envelope for reply. No late or incomplete entries will be accepted. The right is reserved to refuse an entry without explanation. The entry may be restricted at the organisers discretion. Preference will be given to Speedway type machines. No Acceptance Pass - no free entry.
- Yellow Flags: In the event of any course obstruction all yellow flags will be shown around the course. Drivers will reduce speed and maintain position until flags are withdrawn. Any driver deliberately gaining an advantage while flags are out will be excluded. The Clerk of the Course shall exclude immediately any driver who, in his opinion, is guilty of any foul, unfair or dangerous driving. Should the Clerk of the Course decide to stop a race in the interests of safety, then that race will be re-run.

#### **IGNITION CUT-OUTS FOR GRASS TRACK SIDECAR MACHINES**

#### THE FOLLOWING IS A GUIDE ONLY TO THE SYSTEM YOU MAY EMPLOY

The basis of the ignition cut-out is a Burgess 4BR micro-switch which can be obtained from any reputable electrical wholesaler, and this is used in conjunction with a rubber wedge and lanyard.

The switch is to control the low tension circuit and should be installed as follows:-

On many magnetos the contact breaker cover is provided with an earthing terminal but should no terminal be fitted the following simple modification can be made.

The centre of the contact breaker cover should be drilled with a  $\frac{1}{4}$ " drill, a piece of phosphor bronze strip approximately  $1\frac{1}{4}$ " x  $\frac{3}{6}$ " should be drilled with a 3/16" drill near one end and the strip bent to form a U. Pass a short 2BA brass screw through the 3/16" hole in the U and slip on a fibre washer. On the exposed thread place an insulating tube to insulate the screw where it passes through the cover, fit a fibre washer to the outside and lock with a nut. There should be enough thread left to take the wire and a nut.

The U piece should make contact with the securing screw holding the contact breaker assembly when the cover is fitted. The wire should be connected to a "normally open contact" switch and the other terminal wired to the frame of the machine.

#### Operation

The lanyard attaching the rider to the switch operating device must pull clear after operating the switch and earthing the magneto to enable the rider to vacate the machine.

#### Coil Ignition

The switch required in this system is a "normally closed" switch and should be wired between the battery and coil.

Again the lanyard, after operating the switch, must pull clear.


