September Board Commentary

September 1st saw a small, but select(?) gathering of the clans at Wimborne Minster, with apologies from Messrs. Caslake, Goss, Kendell, Allan, and Baines - the latter very busily and, as it turned out, successfully representing us on the Continent; there is a distinct possibility that you will read more of this matter elsewhere, as Ron's bushell is not particularly lightproof.

There was also an apology from the X.H.G. Tigers, although Mr. and Mrs. X.H.G. Lambert were there in force.

The proceedings were opened by Vice-President George Hodges, who apologetically announced "he was in charge". The minutes of last meeting were read by one Arthur Mason, who is rapidly assuming the rôle of the "Deputy". Some say "Good old Arthur".

Regarding the motion passed to circulate lists of entrants, and their alleged club membership they claim title to, in the case of scrambles, etc., Mr. X.H.G. (sorry, Lambert) asked what action would be taken. It would, in the first case, be left to the various club secretaries to lodge a complaint. Jim Rendell thought the rule should apply to trials as well.

My apologies to Les. Smith who, after the reading of the minutes, had "taken charge".

Centre, to discuss Riders' Status, scramble type, had been arranged for September 18th at the Chequers Hotel, Newbury.

National Rally: Enquiry was made about an article on same by the Centre Secretary, but he said he had been unable to prepare it in time for the September issue, but it would be in the October Gazette; winners of Centre awards this year were R. C. Hounsome and B. Longshaw, the former also becoming the first holder of the Bert Collins

Report of the Competitions Committee was then read and the following matters commented on:-

(1) The participation of registered members of affiliated clubs, in Road Safety Trials, organised by Road Safety Committees, etc., was quite in order.

(2) The request from the Auto-Cycle Union for suggestions as to the minimum requirements for protective clothing in speed events, other than road racing.

(3) Appeal from the A.-C.U. for volunteers to organise:-

Inter-Centre Team Trial, March 12th; Grass Track Championships, September 3rd; Road Race Championships, August 7th; Scramble Championships, October 1st. No mention yet made about the two Moto-Cross fixtures, as dates have not been confirmed by the F.I.M.

Roll Call: Sarisbury Green club is now disbanded. Officers present: Messrs. Hodges, Our proposed meeting with the Wessex Jones, and Mason; Chairman Smith, well in charge by now, and Hon. port, Ringwood, Southampton, Southampton Vikings, X.H.G. Tigers (L ain't it), and Triumph Owners (Bournemouth); 32 in all.

Recommendation from the Competitions Committee, re stewards' expenses, to levy the usual 25/- fee from each club organising an event with a paying gate (or car park), and to reimburse (September madness) stewards as follows: Speed Events 15/- and Trials 10/-; same to come into effect on January 1st, 1961; carried. For National and National restricted events, where the organising club has a Centre steward on the panel of stewards, expenses will be paid at the rate of 3d. per mile.

Arthur Mason gave his financial report (new type), which didn't seem much different from the old type. On the Gazette report there was a message from Ron Baines, saying that he had sent out all accounts, and if he could get prompt payment from the clubs, etc., he hoped to get a more charitable comment from the Centre Auditors.

Interim Report on the Grass Track Championships: Chairman Smith was there, and said he had a very pleasant day; Jim Rendell said he thought there would be a profit and asked the Secretary to send a letter of thanks to the landowner.

Report Scramble Championships: All arrangements laid on, but the club would welcome help with more marshals.

Annual General Meeting of the Centre: All fixed up at the Minstead Hall. By general request, Arthur "Utility" Mason will be in charge, as per usual.

National Grass Track: Jim Rendell said the team had been selected and would give of their best; and by reports in the Press, they did have a success too — the Centre Sidecar Team Championship. Well done, the Grass boys!

National Scramble: Arthur Lambert said the team had been selected and he was hoping for another win.

Next Board: Confirmed Basingstoke, October 6th, at the Grapes P.H. Correspondence: Letter from Alton for a trial on December 4th; agreed, subject to East Area approval.

Letter from Triumph Owners, Bournemouth, for an Endurance Test at Stoney Cross, 4th June, 1961; Spec. Res.; agreed to.

Letter from the R.A.C. re shortage of examiners for the A.-C.U.-R.A.C. Training Scheme. Arthur Lambert suggested that we get some sample examination lists from R.A.C., so that prospective examiners could see what was expected of them. Also complained that he was often asked to travel long distances at short notice.

It was announced that the Swindon Club are thinking of transferring their affiliation to the Southern Centre next year.

Letter from A.-C.U. forwarding a complaint regarding the Henley Trial, August 14th; no notice given to the police, and excessive noise causing inconvenience to local residents.

Complaint from Farnham that one of their members sent in an entry for the South Newbury Scramble to arrive first post on the day entries opened, August 13th; and that it was returned on the 24th, with the information that the novice entry list was full. Suggestion that there was a strong smell somewhere, and that the S.N. Secretary be asked to attend the next Competitions Committee to give an explanation. Matter referred to that committee; it was agreed.

Gosport Club asked for permission to organise a scramble, with T.V. coverage, on December 4th; agreed, subject to Area approval.

Meeting closed at 10.34 p.m.

PROOF OF MEMBERSHIP

Dear Sir.

After reading Mr. Mason's letter in the current issue of the Southern Centre Gazette, which I take as being the result of Mr. B. Jones' suspension, I consider him to be rather short-sighted on the matter. Club cards, whether organised officially by the Centre or entrusted unofficially to clubs to carry out their own systems, seem to me to be a complete washout. Agreed, something has to be done, but why not start NOW to lay the foundations for a national scheme, otherwise riders who travel to many Centres will have a pack of club cards to shuffle every week. I know of one Centre where 75% of all scrambles are closed and therefore very

nearly every club in the Centre has to be joined to get a ride. I know. I did my National Service there!

The scheme I have in mind would be run by H.Q. In other words, all riders would have a National Licence; these are already obtainable by novices, so no doubts there. As, at the moment, your first club has to countersign the application for a reduced rate to be obtained, so the same procedure could be applied.

The only difference from the current licence issued should be the addition of the name of the club authorising its issue. The licence would be valid for anywhere in the U.K., as at present. We should then have somebody belonging to a club and having a licence to compete all in one.

Licence cards would be produced at all meetings attended, so that a constant check could be kept.

Some clubs might bemoan the loss of a few 5/-'s, but if any rider wishes to join another club he will do so anyway. Other advantages are: — H.Q. would get some more funds to assist National teams, etc.; club programmes would bear a variety of clubs entered in the list of competitors. From this the public would soon see who the real local stars were and who came from some far-off place. Not as at present, where a good 60-70% of competitors all ride for the organising club. I hate to think of the number of honorary memberships (for the day) that I have had given me from time to time.

I trust this will throw new light on a sore subject and would like to hear your comments. I think that it is something which could work very well if organised properly.

A.-C.U. XVIth NATIONAL RALLY — BELLE VUE, MANCHESTER, 9th/10th JULY, 1960

I rather imagine that it is the dream of every reporter to have to write an article on the same event year after year and be able to report bigger and better results. I feel a certain pride in being able to write the story of the Southern Centre for the third year running and achieve that fact.

To recap to the 1958 event which was held at Weymouth, I was invited to represent the organising committee and go to Esso (Fawley) M.C. & L.C.C's. clubroom and present them with the Premier Team award; at the time I said that it was to be hoped that as this was the first occasion on which a Southern Centre club had won the award that it would be the forerunner of better things.

This year has produced one such effort and our congratulations go to I. Rinn, who entered in the name of the MG/Riley Auto-Club and was awarded the Premier award, namely The Varley Challenge Trophy, riding a 250 c.c. Matchless.

Of the 120 control points (including Manchester), 13 were provided and manned by Centre clubs, perhaps for not such long periods as in previous years, but this year one of the starting points was at Hartley Wintney (North Hants. M.C.) and 385 competitors arrived to start their 600-miles journey at 10 a.m. on the Saturday morning.

This year's total entry of 1,086 was 61 below the record and of that number 55 entries were made in the names of Centre clubs, which is again an increase on previous years. The weather must have had some effect on performance as the number of non-arrivals was up to 18. The summary of the results is as follows:—

Of the 55 entries—21 Special Gold (maximum points)

11 Gold (600-674) 4 Silver (500-599) 1 Bronze (400-499) 18 non-arrivals

D. Lloyd (M.G/Riley A.C.)—3rd-Class Award (Class "C")

B. Longshaw (Riley A.C.)—3rd-Class Award (Class "G")

The Southern Centre awards:-

- R. C. Hounsome (Southampton Vikings)—Velocette—Solo. (Final +0.4)
- B. Longshaw (M.G/Riley A.C.)—Royal Enfield—Sidecar. (Final +6.0)

On the overall performance R. C. Hounsome will be the first holder of the Bert Collins Trophy.

On closer scrutiny of the programme I noticed that there were several entries which were recognisable as members of Centre clubs, but who had entered in the name of their home town or National club name and, of course, will not appear in the Centre record. Triumph Owners, Vincent Owners and C.S.M.A., all of which have local branches, were not mentioned; similarly, Portsmouth and Southampton were two of the towns I refer to.

Wtihout wishing to make special reference to any of the other competitors, apart from those already mentioned, I feel some words would not be out of place when I refer to firstly Mrs. D. M. Street of Waterlooville M.C.C., who gained a Silver with 580 marks and was the only lady entry from the Centre; the second was P. A. Jewell who, as in previous years, made the journey from the Isle of Wight to the mainland and won a Special Gold with maximum marks.

So far as the Centre is concerned and those drivers who competed, this has certainly been a successful year and our congratulations go to all concerned.



ACCIDENTS AT SPEED EVENTS

The Competitions Committee considers it advisable that promoters of all speed events should be asked to take steps to ensure that, when an injured driver is removed to hospital, his crash helmet and protective clothing be sent to the hospital at the same time, and promoters are requested to make the necessary arrangements with the Medical Officer and ambulance officials.

In issuing this directive, the Competitions Committee is guided by a report that at a recent road race meeting a driver was discharged from hospital after treatment, but subsequently another hospital diagnosed a head injury. It is felt that had the driver's damaged helmet been sent to the hospital at the time of the accident, the need for an examination of his head would no doubt have been apparent, even though there were no outward signs of injury.

There are more than 100,000 people using these sticks in Britain today and all of them must rely on the motorist and the motorcyclist being their eyes and ears.

The Royal National Institute for the Blind tells us that the difficulties of blind people have increased alarmingly because of the heavy traffic on the roads today. This is particularly true of the newly-blind—of which there are about 12,000 every year.

Some of the newly-blind are children, but about three-quarters of them are people over sixty years of age. The handicap of advanced years, coupled with a new, sightless life, creates enormous problems. Many of these people also have the handicap of deafness and for them the difficulties are greater still.

"Road users can do their bit to help everyone so handicapped by showing extra-special courtesy whenever they see a pedestrian carrying a white stick", comments the R.A.C.
