

#### AROUND THE CENTRE

Although I have covered the main part of the Newbury Super International elsewhere in this edition, we must start off this month with the racers and the part centre runners played in the par National supporting races of which there were three, combined for an overall result. Having perhaps lost touch with who is capable of what, I must admit I did not realise we have in our midst three genuine national riders contending for major honours, and all being on the up and up as opposed to the near retirement stakes. Mick Jones and Les Lloyd are of course no longer new names to this column, but nevertheless their progress toward major distinctions is gradually reeling in the Wades and the Robertons of this scene, and the takeover cannot be that far away. If they do not look out however they might just get pipped to the goal by yet another of our's namely Grayham Noyce. Having Don Rickman as heir apparent to his toolbox must be everybody's dream, if in fact many of today's lot do dream, thus we must respect D.J's judgment when he says he is on to a winner. Judging by Newbury's events I would conclude that he is not a bad judge, though I doubt whether my opinion holds great deal of handle; but seldom have we seen a seventeen year old participating with so much ability as the Rickman runner showed and what is more still be in contention at the end of each race. The pit lane at the Fox & Hounds was extremely quiet actually, which on a day when the dust clouds were of density nine was very refreshing.

I took the opportunity recently of attending the finishing area of the South Hants Soc's Vintage run near Alton, and I must admit my ignorance, yes more of it, of the enthusiasm directed to the veteran belt and leg driven machines of 'El Alamein' and before. Seeing one mint condition kahki M20, made me pause to imagine the plight of those message bearers during the last war, or even for that matter until such contraptions were taken out of service. Hardly the ideal motocross device, panniers and all, but even so no doubt saviour of many lives. Anyone who saw the film the 'Great Escape' will no doubt recall that Mr. McQueen took off on his bid for freedom on just such a vintage device, possibly of 'Achtung'

decendancy, but as soon as the super lift off stuff was needed was suddenly very similar to a T.R.6, the current Meriden high charger at the time the film was made. Not that one can blame him for not wanting to presume too much of a girder forked machine, it was perhaps cheating to the same extent as that noble art of self defence, commonly interpreted under the heading of Football. Anyway to return to the vintage run, it was nice to see George Hodges, possibly our leading Centre Vice President, cut enjoying his thing, proudly announcing a trouble free run, and over a twenty mile course I understood to be pretty unique.

Looking forward in the calendar, I have come across the distinct erasion of the Jersey Two Day Event, not that it is not a jolly good weekend, but more the thought of all that water in between us and them. No longer a person of gay abandon at even the smallest of goldfish ponds. I find the thought of spending half an hour thousands of feet up in the air in Longfellow's company absolutely suicidal, sealed plane or not. The point of raising the matter is however the extreme shortage of available places this year, so if you wish to be part of the '74 St. Helier Landing' now is the time to book up.

The annual plea is now upon us all for funds to send the I.S.D.T. teams to Italy and in this day of wealthy sponsorship it is surprising that team leader Ken Heanes is still expected to sell his soul for this cause, and not the least damned humiliating for him. Here we have a supposedly national effort, only one step from success last year, on a beg steal or borrow campaign to get the show on the road, which if known to our competitors must make us look the poor relations. Somewhere along the line this event has either to be recognised on a par with a Moto-Cross Des Nations effort, or else sold to the highest bidding fag maker so that our chaps are not wearing threadbare blazers, even if they become known as the 'J.I.P.T.' John International Player Team. So I know Ken would have to take up the dreaded weed, but having yet to see Jeff Smith get through one, can't believe the problem insurmountable. Seriously though, it is galling to read that though we could actually win the event, our chances are spoiled, or perhaps stained is a better word, purely through lack of support. Just look at the television coverage of this year's World Cup, and we didn't even qualify. Not that this medium has been renowned for its motor cycle coverage, in fact if they went to Italy to cover the finish we could be sure they would probably send that well known and well versed commentator say Eddie Waring?

#### BOARD COMMENTARY

The Board met on the 1st August, 1974, at Southampton Motor Cycle Club Headquarters by the Club's kind invitation, again thanks for your kind hospitality Southampton, and for a second month in succession we stood in silent vigil for dear Charlie Phippen and how we shall miss him. Again our George Hodges deputised for Joe Caslake of whom we hear that he is moving about again and that Peter Ryall is again on the mend and is about to go home.

Apologies were proffered for Messrs. Caslake, Ryall, Mellors, Bussell, Appleby, Kingswell, Challis, Lightfoot, May, Sturminster Delegates, and last but not least F. J. Rendell.

The Minutes were adopted subject to a minor addition.

Our George then handed over gavel and mike to Premier Brett, who proceeded to hear matters arising for July Minutes.

He first, however, thanked Southampton for provision of amplification equipment. (The next piece of Chairmans equipment will be a Levy Water Pump with direct mouth dispenser, reason for this latter you will appreciate later). The missing trophy is to be replaced with the help of Mr. Hardware Jim. Ken Heanes thanked the Board for International Six Days Trial donation. Jim Rendell to be asked to confirm August Torquay Sports Council attendance. Mr. Steward's father is actually presenting the Steward Trophy.

Bishops Waltham Grass Track Sub-Committee wrote an interesting letter accepting Board decision, but asking for advice arising from same. Scribe Broad requested to write with advice that there were no area boundaries, but Clubs were expected to respect other Clubs operating near the Club's proposed venue, especially as towards causing agro with locals, who might find motor cycle events too frequent to stomach. Police and Local Councils permissions do not have to be obtained, but notification of impending events is diplomatic. The exception when an event is held on M.O.D. Land when the latter insists on same. Just common sense, lads: follow Countryside Code and share the countryside with your fellows who possibly can make it difficult, if not impossible, for Motor Cycle Sport to continue. Get the first word in before rumour starts. Be the first to be willing to share.

The H.M. Governor read the roll call. We found 11 Warders, 27 Inmates, representing 18 nationalities. The Post found a Moto-Ball Association had been re-vamped at Basingstoke, information obtainable from John Kelly. Copycat London have ideas of following the Southern's Trial Marking with ideas of taking this to the F.I.M. This had been discussed by our own Competitions Committee.

The 4-wheeled Gang informs us a new RAC/ACU examiner at Southampton, Mr. Cecil Milne; also at Newbury a new Training School has started (or restarted?) by G. P. Evans, Esq., Newbury Road Safety Officer.

London again have over-ordered 1974 Handbooks, are available ex London free, providing return postage is sent. Riders are recommended as they now contain Standing Regulations for Speed Events and Trials.

Derby Phoenix Motor Cycle Club had kindly thought of us (don't be sarcy, be friendly) by offering quite illegally to invite us to participate in a Restricted Event. For those who don't know, restricted events are only inviteable to two adjoining Centres.

The Premier's Club (not the Guards) again want to chop their Pathfinders Trial from 13th October to 6th October because of Royal Automobile Club Rally regulations. We give our blessing just because they are the only Southern Centre Club running a Green Lane Trial, which is subject to Rally Regulations.

Come Lassies and Lads; someone else have a go. Wimborne had to change Grass Track venue for the second time. Their castle's drawbridge has collapsed to North Farm, Horton. West of England asked for approval of Restricted Scramble Invitation for 2nd March, 1975. Agreed.

Bad Boys Reports given out for personal collection. Premier Brett deputised for Tony Bellenger at Competitions Committee meeting. Messrs. Moss and Cooper had not paid fines, and therefore had been reported to London for disciplinary action. Probationary Steward Bedfoes had offered to resign because of inability to attend Competitions Meetings during one season of the year, had been brainwashed by Roger the Broad, still no luck, so Premier Brett persuaded him to carry on. Gosport and Wimborne had certain items brought to their attention.

R. Wood had been fined £5 plus £1 costs.

Sturminster Newton had finished late on a Sunday event, and Clubs have their attention drawn to the gentleman's agreement to finish Sunday Events by 18.00 hrs.

Ray Brett had contacted Mrs. Lowery. She still does not enjoy the best of health, and is moving house in September, and she will attend to Trials riders registration.

The Grass Track Championship which is to be organised by Winchester, whose Racing Secretary reported entries were coming in nicely.

Three Hat (Trick) Harry reported Naughty Boys wanting travelling monies for riding at Mere, Wilts (not Cheshire) for the Inter-Centre Grass Track Champion-ships, which are on 25th August, 1974 organised by the Blackmore Vale Motor Cycle Club. Various people spoke on this unsportsmanship and Harry was told the Board would back the Sub-Committee's obvious actions. Expenses should only involve the entry monies.

The Saints of Sarum, who organise the St. Pauls as a Grass Track Event asked for the event to be held on 22nd September instead of the 29th September. Approved.

Mr. Collins of T. T. Supporters Club reported on the Club's Annual General Meeting held at Fort Dunlop, Birmingham.

Calendars, Silverstone Stand, Bob MacIntyre Tie, Scarves, etc.: you name it someone leaves no stone unturned. A full report as only Friend Collins can present. Thank you.

The Chairman, Secretary, and London's Manager Mr. Bracher had attended a Seminar at Crewkerne a few days previous to the Board Meeting, together Seminar, organised by South Western Region Sports Council was with particular emphasis on motor cycling. Apparently we are World's Worse advocate, as far as with neighbouring South-Western Centre representatives, including Wales. This our Sports' outlook to the Authorities and the Public. South Wales has a project at Tredegar to cover Trials, Scrambles, Road Racing and Grass Track costing £1.5m.

Although no vote of thanks was given from the floor and the Premier ignored his charger "braying" (White Horse). The Centre Nosh Up is beginning to really stir, so late comers hurry up or it will be too late. If you cannot, please donate a raffle prize.

The Trials Sub-Committee had met at Basingstoke and a limited circulated report had been circulated. Mr. and Mrs. Lambert, Tony Belenger, John Mould and others spoke with some feeling and a final result was not achieved. It is obvious that it is at present unable to state which is a League Trial (before the event) under present rules.

Rights of Way was a Western Area Report on a meeting at Dorchester attended by Broadbery and two co-horts about procedure for objections to the Review Map.

The Southern Centre National Rally winner was P. Wilkes, and the Board congratulated him.

Again a late ending - at 11.30 p.m.



#### SUPPLEMENTARY REGULATIONS:

- 2. Eligibility: Open to all members of Southern Centre Clubs, riding solo trials machines.

- 4. Course: Will be approximately 1½ miles of 10 sections per lap. Any rider exceeding an average speed of 24 m.p.h. will be excluded. Session one will start at 11.00 a.m. for novice riders. Session two will start at 2.00 p.m. for intermediate and experts. The number of laps to be displayed at the start.
- Penalties: Observation will be on the 0-1-3-5 system. 2 marks a minute, or part of, will be lost over standard time. 10 marks for missing or not attempting a section. The course will close (to be decided on day) after standard time in each session.
- 6. Awards:

Premier: PRESIDENT CUP

This award is perpetual and a replica will be given.

All class awards as per Centre Ruling.

- 7. Entries: To the 'Entries Secretary' on the correct form with a fee of 80p and two large S.A.E. must be included. Entries open on the 7th September and close on the 21st September. Entries will be limited to 40 in each class.

### THE BRITISH SIDECAR MOTO-CROSS GRAND PRIX

(The day they moved Newbury two miles to the North)

It didn't really matter that the temperatures were in the high 70's for there was no way those interested in this event would be tempted to deviate from the trek to the Fox & Hounds venue for the third of the Newbury's spectacular by kind courtesy of John Courage, the liquid refreshment firm. Mentioning individuals of any club promotion goes against the P.J. grain, but on this occasion I would be failing in my duty if I left the names of Dave and Sally Joyce out of print, such is their part in this promotion. Newbury are responsible for the birth of this brainchild, and of course it has become the major meeting of the year in this country, probably due to our having at least three crews capable of carrying off the spoils backed up by the whole spectacle of chariot racing.

This year the whole effort was one tremendous enthusiasm, and in witnessing so much honest endeavour more than made up for the subjection to the 'desert rat' conditions that prevailed. A programme of five events ensured a full day's entertainment, without the use of floodlights, and at the same time did not include worker type races which really have no place at an International meeting anyway.

Of course the real question was whether since last year the whole deal had accelerated away from the capabilities of our runners, or if, with the injection of new young blood we had kept pace. The fact that Nick Thompson was lying second to the acclaimed champion Grogg, could be misleading if one realises just how damn fast he is abroad, and how little good fortune he seems to have over here. We need not have worried though, for after timed practice all five of our runners were on the front row of the two line grid, and although we lost John Turner immediately afterwards, when they blasted away from the line in the first race Terry Good, The Logans and Nick Thompson were all fairly well up and even though John Elliott was well back, it was obvious after a few laps that he didn't intend to stay there. For Good the first taste of Grand Prix racing, found him fending off one challenger after another and although he slipped from his original fourth spot, it was not until two thirds distance that he drove out of one of the many tight corners that he overdid it and crashed. Even so he picked himself up to finish twelfth, more than silencing the critics who said he had no right to be out there. Thompson strove towards the front with tremendous determination, and no doubt helped by the home crowd finally annexed third spot before time ran out on him, and Elliot ploughed through the worst of the conditions to finish an excellent eighth.
