

AROUND THE CENTRE

The past month has seen the last of the home grand prix events, covered elsewhere in this issue, in which Britain provided the winner, a war of worlds over the two solo rounds that could be summed up under the heading "The Nag Fight at the O.K. Corral", a national trials win for Geoff Chandler, and a 500 G.P. debut by Graham Noyce that left no doubt where his future lies. In that small paragraph lies more action than has been provided for a long time. Turning first to the alleged low score marks we received for the aftermath of the Hawkstone epic, it is interesting to note that the critics were helped no end in their efforts by two virgin comic reporters interested only in projecting an image of a cowboy outfit made up of cream tea types. Now whilst nobody is perfect, it is hardly the attitude to adopt if they, like us, are at all interested in the future of home moto cross, especially when their wealth of experience doesn't stretch much further back than my two-year-old. Perhaps it is time for the governing body to try and obtain more permanent circuits and for clubs to pool resources for such big events, but as to tell us we are all cart before the donkey then that is too much, just because a few super stars get the hump about racing in dusty conditions.

Without being accused of starting the Noyce appreciation society, it would be most improper to continually dwell on the progress of the Fairoak Flyer, but his exploits during the Newbury Tavern Moto-Cross, the three race supporting feature at the Fox and Hounds, were sufficient to warrant further comment. Having watched our home champion cast his machine to the ground at the start of the first leg, having already had the benefit of a re-run caused by his own doing, we were not only treated to riding of a refreshingly different kind, but also to two bouts of trackside fitting that only just prevented his winning overall. It was at this meeting just a year ago that this young man really started putting it all together and with a 500 G.P. fourth place at only his second attempt, and that on foreign soil, we surely must be on to something good. Also his impending selection to ride in the two world team races, well it was impending at the time of going to press anyway, must rank as the best progress for many years. And so we ask ourselves how could this happen at the age of eighteen, when most have only just worked out the direction of the throttle. Well whether people

are for or against the sphere of schoolboy scrambling, they must thank this movement alone for grooming such a star. And this is not the only one by far, for it is noticeable that all the good schoolboys have no problem in scoring enough points during their first six months of Senior sport in order to attain Expert status, thus the meeting between the two bodies that is to take place in September in this Centre will do more for the future of scrambling, if succesful, than all your snide comic ideas put together.

One unbiased onlooker, whom I shall excuse from any inference, is our old friend at Trayford, for he has long been a campaigner for the Youth Movement, and it is to two more of his hobby horses that we turn to next. The first is the series designed to combine speed with trials which has enabled Willie Budden for one, the honour of sowing the Union Jack to his riding suit for this year's Isle of Man ISDT. With trials possibly the most important background needed for the international, then what better way to develop the speed angle than the Southern Counties events. The next favourite of our Ralph, is his obsession to prevent the four stroke scrambler from becoming extinct. I don't think he would be loosing much sleep at present for even on a national front these machines, by courtesy of the Bolton organisation, are capable of being competitive. The Championship solely confined to these mounts, whilst strongly supported from the financial angle, is not quite as well backed up by the competitors. At Winchester's July meeting the off sounded absolutely fantastic but the competition up front after a few laps was very sparse, which was a pity for when it was all over and the run of the mill stuff started again, my headache came back.

It doesn't take many weeks of absence for Geoff Chandler to shove his oar in, and his win at the Allan Jefferies event was not only overwhelming but about as subtle as a poke in the eye with a lamp post, when we realise it is the second national of three held in the northern part of the country that he has won. With the home importers of his type of works machine on his doorstep, it is interesting to see that rather than just bank all the sales monies they are becoming involved in the development of the bike. As the summer months pass by new nails for trials are being purchased and whilst many have made inroads to catch up, nobody seems yet to have overtaken the machine that first arrived from abroad in the hands of Sammy Miller, though in fairness to that factory they have continued to develop despite Sammy's switch to an old love of his.

Inter Centre speed events are now upon us and the Grass Track Team I believe are the first into battle. Undoubtedly the best supported sphere of racing in this centre, it always manages to attract stern competition for the honour of representing us. The fact that four classes are contested at the annual event means of course far greater numbers being involved than say the scramble of trials events. Nevertheless it was nice to hear the O.K. given at Board level for the expenditure especially with the ever increasing costs of travelling. It has always been the Southern Centre policy to support and promote its riders, and with former days of glory passed by, it is particularly noteworthy that just because we don't have a full list of household grass names, the opportunity to cop out is not used. Tales of dense dust at racing meetings have made this summer's events ones of real foreign legion stuff, especially for the second event at a same venue that had little or none of the wet stuff in between. Still we shall never be satisfied whatever the weather, the only thing is to get on and enjoy our sport for that is more than a great many can do.

BOARD COMMENTARY

Congratulations and thank you SOUTHAMPTON for air-conditioning your Club House for us SOUTHERNITES, especially those who had travelled that August evening any distance over an hour.

Our worthy Vice-President George Hodges opened the proceedings welcoming everyone and receiving apologies from Messrs. Salisbury, Waterlooville Clubs, Brian Coombes and Phil Mellors. The minutes were received and approved.

The hammer, but not the sickle, were handed over to "Whippet-Quick" Roy who weaved through the matters arising.

The Rules Revision Committee are to convene on 1st September to finalise the revised rules. Rule 313 Saga continues; with London bringing out a New Notice of Motion still using the Club numbers as a basis for calculating the London Delegates; still Rodger's proposal to calculate the number on the number of a Centre's affiliated members is in hand. In any case why change the present system, especially as Centres will pay delegates travelling fees in future? Neville Goss and George Allen spoke for the Southern Centre Motion which is to be proceeded with, and Jim Rendell rose to thank Rodger for his homework on the Notice of Motion.

Taunton Motor Cycle Club have not replied to Rodger Broad's letter of complaint re the non-notification of acceptance or rejection of entries.

The Roll Call was called-15 Officers, 55 Delegates representing 22 Clubs were present.

George Allen rose on behalf of National Rally Committee to congratulate the Hampshire Constabulary Club on winning both the DUNLOP and MOTOR-CYCLE AWARDS. The Board congratulated the Club, and the Centre Secretary is to write congratulating Hampshire Constabulary, proposed by Jim 'the West' Rendell.

John of the Kissinger fame has received a most amenable letter of dates from Mr. Allaway. It is obvious the new broom is still puffing ye olde Pipe de Peace.

London had forwarded a further £290.00 grant which was received with acclamation.

Mr. S. Palmer of Swanley has been suspended until April, 1977.

A notice of motion was proposed by Rodger Broad that the Centre President shall be elected for a maximum term of three consecutive years to be moved at September Board Meeting.

The Centre is sending two delegates to Barton Hall, Torquay on 1st November for a South-Western Sports Council week-end.

- 5. Penalties: Observation will be on the 0, 1, 3, 5 system. Two marks a minute or part of, will be lost over standard time. 10 marks for missing or not attempting a section. The course will close after standard time in each session to be decided on the day.
- 6. Awards: Premier—Presidents Cup. This award is perpetual and a replica will be given. All class awards as per Centre Ruling.
- 7. Entries: To the 'Secretary of the Meeting' on the correct form with a fee of 85p and TWO LARGE S.A.Es. must be included. Entries open on the 7th September and close on the 21st September. Entries will be limited to 40 in each class.
