Extracts from the Past by G.H.

GAZETTE JULY 1936

The Centre Speed Championship Meeting is again approaching, and the question of Awards to the winning competitors has been settled for Cash or Cups of the same value, as desired. In addition will be the Solo Championship Shield and replica for the fastest time made at that meeting, also the Speed Championship Shield to the Club whose members riding as competitors at the meeting obtain the highest points on aggregate.

Points will be allotted for First, Second and Third places in heats and finals, and cash awards will be paid to individual competitors in accordance with the number of points obtained. It is anticipated that the entry for this meeting will include all the finest riders in this Centre, and in participating in the sport they enjoy, will provide the public who make these events possible, with the best racing and riding in all events for which entries are made.

Riders should remember they have a certain obligation to the public, when their names are printed in the Programmes and should be prepared to carry out that obligation in each event.

The next meeting of the Centre Board will take place at Cadnam - The BLUE COTTAGE, on Monday July 6th, at 8 p.m. The last meeting was a great success having regard to representation of Clubs. These included the TWO new Clubs of this Centre, ITCHEN of Winchester; and the CHICHESTER Club who have now rejoined this Centre. Will Trials Secretaries please note that this Club has some good trials riders, and also stage some very good events in their district, but are at present not blessed (or otherwise) with grass track racing enthusiasts.

There are Three Tracks on offer for the Centre Speed Meeting: Cannfield, Salisbury, and Basingstoke, from which the selection will be made at the July meeting of the Board.

LETTER TO THE EDITOR

Dear Editor.

Referring to the question by your correspondent in the June issue of the Centre Gazette, writing under the heading of "QUO VADIS". The answer seems fairly obvious.

All these very regrettable happenings will not be completely negated - fortunately they are not yet a component part of every Grass Track Meeting - until the game is completely professional - and governed in the same manner as the sister sport, Speedway Racing.

Personally I was bred in an atmosphere of Cricket; where the fundamental tradition, in modern parlance is "You don't do that there 'ere". I grew up with an inherent interest in Motor Cycle Sport, and have seen unmistakably, the metamorphosis from the so-called sporting atmosphere to commercialism.

Fortunately perhaps, there are no traditions in the sport of Motor Cyclng, which in these times of modernity, makes things not quite so difficult.

From the "HONOUR" the award list has graduated through "POTS" to Pounds, Shillings and Pence, but the administration has remained stagnant. This is one reason for the regrettable occasion referred to above.

Recognise therefore, that while riders have insisted on £-s-d - and they didn't say please - the whole sport should be put on a commercial basis.

There are Laws issued by the A.C.U. Is it reasonable, that a few public spirited

gentlemen, should out of an inherent good nature, shoulder the responsibility of applying these Laws, as officials appointed by the A.C.U.?

Under the leading officials I would include Stewards, Time-keepers, Clerks of the Course, and Pit Marshals, etc. These should all be put on a basis of financial remuneration. A roster should be kept of those eligible to serve, not necessarily those willing. You don't hear of riots and insults of officials at Speedway Matches.

When this is done, rider, management, and the public, on whom the whole movement is dependent, will get a fair show, and the riders will know the penalty of misbehaviour - I don't think they have all realised this so far.

The regret expressed by some members who are very much against accepting a fee, is hardly consistent with a negative desire to volunteer or accept the suggested Honour of Stewardship at a Grass Track Meeting, I am quite in sympathy. Officialdom is not anyone's job. The aim to be reached as Georg Allan would say, is efficiency in administration. The public pay One Shilling and Three Pence per head for this, and the sooner all concerned realise it the better.

In spite of a possible inference that I have a personal axe to grind. I sign myself, B.S.

BOARD COMMENTARY

The Annual Meeting of the Southern Centre Board held at the Abbey Hotel was opened by Mr. J. Caslake, M.B.E. Apologies were received and the previous meeting's Minutes were signed as a true record.

The Chairman, Mr. R. Brett, then took the remainder of the meeting. He reported with regret that Mrs. G. R. Allan had died, sympathies had been extended to George Allan.

The Roll Call revealed 14 officers and 38 delegates representing 17 clubs present.

As usual there was a mountain of Correspondence, an Application for Affiliation had been received from Thames Valley (South) M.C.C. A representative was unable to be present; an Invitation will be made to the Club to attend the next Board Meeting.

The A.C.U. had decided to drop the proposed change of Centre Boundaries. The Centre agreed to send Rodger Broad to a Conference of Centre Secretaries in London on 23rd January.

3½ LEVIES. Clubs registered with V.A.T. should complete duplicate forms, quoting A.C.U., V.A.T., Reg. No. 238/5704/48 or send usual Levy Form requesting a V.A.T. Invoice.

Waterlooville Club asked for another track Inspection as their course was now restricted to only 16 Sidecars as compared with the original 20 allowed on the Start line. They are to apply to A.C.U. London.

Mr. Phippen reported on the Inter-Centre Scramble Championships. He stated the Centre team had been dogged by bad luck, that the organisation was not good, particularly the lap scoring. The Chairman thanked Mr. Phippen and the team for their efforts.

The A.C.U. General Council Meeting was attended by Messrs. R. Brett, R. Broad, N. Goss, P. Ryall and K. Gale. Some points of interest were mentioned: Coloured No. Plates were being looked into; the New Pirelli Tyre has been Passed. It was proposed that all Motor Cycle Sport be stopped in view of the Fuel Crisis. Mr. Goss stated that the Southern Centre wished it to continue on private land, rather than have unofficial practice.

The F.I.M. set new noise limits. Trials 84 decibels; Moto-cross 92 decibels; to be enforced from 1st January, 1974.

A Notice of Motion was agreed by the Board that the proposal of a 5% extension on each levy should be made on each driver per meeting, to be discussed at February meeting.

Mr. Collins, the Centre rep for the T.T. Supporters Club, reported on a meeting at Fort Dunlop, Birmingham. Groups of 3 persons to form local Committees are to be set up; Mr. Smith was one volunteer. Suggestions for raising funds would be welcome - a 'Miss T.T.' being one.

The Annual Report for the Southern Centre was read by Rodger Broad. Mr. N. Goss proposed the report be approved, Mr. Lambert seconded. Mr. L. Southwell congratulated the Secretary on his report and on the good work he had done in the past very difficult year. It was proposed by Mr. J. Bussell that normal honoraria be paid to officials. Mr. L. Southwell seconded and all approved.

The Treasurer presented accounts for payment. Mr. H. Bone proposed they be paid. A draft balance for the Centre and the Gazette was then read, and accounts



Annual Report of the Board for 1973

The twelve months of 1973 have proved to be full of endeavour and well loaded in work, to the good of the Sport, with a new Secretary of the Southern Centre, Rodger Broad. It was in the year that our President, J. Caslake Esq., M.B.E., attained his 80th birthday.

At the beginning of the year our farmer friends were hit with the outbreak of swine vesicular disease. In an attempt to ensure that motor-cycle sport was not to blame, and could not be accused of causing the spread of the disease, all motor-cycle sporting activities in the Southern Centre were suspended. It was not until assurances were received from the Health Authorities that no danger of the spread of the disease could be caused by motor-cycle sport did the Executive Committee, backed by the Board, give clearance for 'our sport' to continue in the Centre. The co-operation of all Clubs concerned was fantastic and very much appreciated. There was no change to the number of affiliated Clubs to the Centre, and there was no change to the fact that most of the effort comes from too few 'workers'. Land is still scarce and being lost not only to development, but also to car club activities.

Riders have again experienced difficulty in obtaining rides, and the appropriate sub-committee (Grass Track, Scramble, and Trials) have endeavoured to ease the situation by their understanding manner in handling permit issues and date changes.

All Board meetings were held at Romsey but alas the arrangements for the coming year will be made without the friendly and convenient venue of The Abbey Hotel, Romsey. Our hosts for so long Mr. and Mrs. Wineham have our grateful thanks for their understanding and patience over the years, and our good wishes for the success of their new venture. It is fortunate that the Competition Committee can continue to hold all its meetings at Romsey, but upstairs. All meetings have been well attended as have the General Council meetings in London, where the Southern Centre has been fully and well represented.

The financial position of the Centre remains in good health and our thanks must go to the Special Finance Sub-Committee and our worthy Treasurer Ken Gale. Although increases in expense rates were agreed some time ago, it cannot be allowed to pass without the comment that Centre Officials and Committee men have kept their claims to a minimum. The Gazette is also thriving and Editor Colin Holdstock is to be congratulated for his success in maintaining good issues in good time. Postal services are the only complaint, but who can take the blame for that? A new Board Commentator, Mrs. Joan Venes, has kept all readers well informed of Board Matters and follows well the traditions of past Commentators. Jem May (PJM) has made a number of issues of the Gazette and his mixture of fact and natural wit has been appreciated. The Board Minutes, compiled so well by the Minute Secretary, Mrs. Joan Steele, are circulated through the offices of the Centre Secretary, to all Club Secretaries and Centre Officials to impart information with minimum delay. The task of Minute Secretary is an unenviable task and takes concentrated time and effort and invariably gives rise to more Brickbats than thanks.

Harry Bone continues to look after the interests of the less fortunate, and continues to urge all Clubs to greater efforts to raise funds for the Benevolent Fund. He regrets, as we all do, that no money came from the St. Paul Trophy

event as no such event took place this year. It was unfortunate that Gosport Club lost their course otherwise there would have been a different tale to tell.

Due to complaints of poor service at the Top Rank Suite, Southampton, it was decided to look for another venue for the 1973 Dinner/Dance. Unfortunately no alternative venue could be found in time and it now means that we shall all have to wait until October 1974 to enjoy the social function of the year. It will be held in the Northern Area at Reading. It is hoped that the long wait will not dampen the enthusiasm.

Rights of Way matters have continued to receive attention and the Sub-Committee is still very active under the Chairmanship of Ralph Venables. Mick Brown has moved to West Bay and felt that he could no longer act as Southern Area delegate. He deserves many thanks for his past efforts in R.O.W. and it is hoped that he will be able to assist in his new home area. The first winner of the Byeways Trophy, generously and anonimously donated to the Centre, was Mrs. Penny Page, a stalwart in safeguarding the Green Roads of the Centre. Our Permit Secretaries, Mrs. Vera Lambert, Mrs. Freda Bone, and Mr. Ken Nicholas have been extremely busy, and also plagued with late applications for permits, a situation that must improve in the coming year. The number of permits issued were:

Trials: 3 Regional Restricted; 58 Open to Centre and 99 Closed to Club (All in spite of Swine Vesicular).

Scrambles: 2 Regional Restricted; 23 Open to Centre, 3 Gymkhanas, 1 Hill Climb, and 4 Moto Ball Matches.

Grass Track: 1 Regional Restricted; 28 Open to Centre; 5 Closed to Club; 1 Expert Championship; and 1 Novice Championship. This number of Grass Track permits represents the largest number issued by Freda in any season since taking office.

The Centre has done well in International and National Road Racing as such events have been most ably organised at Thruxton by the Southampton and District M/C Club. In the Scrambles field the Centre has again done exceptionally well with Newbury, Waterlooville and Mortimer organising National events, and Newbury, Ringwood and Portsmouth taking on International events.

Centre Events were organised as follows:

Centre Team Trial was organised by Wimborne, the winners being X.H.G. Tiger Club and the Individual winner was Sammy Miller.

The Centre Scramble Championship was organised for the third year running, by the ever-ready Mortimer Club; the winners being - 125 cc. Graham Noyce, 250 cc. Roger Snoad; 500 cc. Les Lloyd; Sidecar John Elliott and Andy Greenhorn and the Winchester Club winning the Kay Caslake Trophy.

The Experts Grass Track Championship was ably organised by the Bishops Waltham Club, with Dennis Lemon retaining the 250 cc. class; Colin Sweby taking the 350 cc. class and Bernie Leigh the 500 cc. class. The Sidecar event was won by Tony Smith and John Baird.

The Novice Grass Track Championship event (not a Centre Event) was organised by Wimborne Club and the winners were; 250 cc. Graham Simmonds; 350 cc. Dave Purchase; Sidecar Colin Chapman and Steve Walker. It is noted with the deepest regret that there were two fatalities in the Grass Track branch of the Sport. The two riders Brian Stewart and Gordan Hambridge will be sorely missed.

The Southern Centre has supported all Inter Centre Events. In the Trials

we finished 4th. In the Grass Track we finished 8th, and in the Scrambles we finished 5th.

The T.T. Supporters Club was formed during the year and the Centre representative is Mr. T. Collins who has attended meetings on our behalf.

An attempt to co-operate with the Junior side of Motorcycling and to ensure that there is a uniform approach to the needs of the Sport was made by the A.C.U. and Mr. George Allan and Mr. Walter Hall represented our views. This matter is continuing.

A new full Steward was made up from Trainee; that was Mr. Dennis Kingswell, a most energetic man in many branches of the Sport.

Some query was raised earlier in the year regarding the boundaries of the Centre and some tentative modification proposals were received from the A.C.U. This has been resisted and it has now been agreed that our boundaries will not change.

Noise is still a matter of concern for the Sport and although we have not heard a great deal of the 'meters' they are still about and their use will be continued. At the very least we should be able to say that when we organise events, these events will be at a reasonable noise level. In many places our sport gets bad publicity but be sure that noise is our worst enemy.

Individualistic soft headwear at Trial events are in danger of disappearing but so far the new ruling on wearing safety helmets applies to events using the public highway - once you are on the road, on goes your safety helmet. The opinion of the Centre is that riders should be able to make their choice whether to wear or not when on private ground. We shall see.

In conclusion, as previously stated, this is the first Annual Report that we compiled together, it is hoped that it will not be our last. We would wish to thank all Officers, Delegates, Competitors, Clubmen and to the ladies who support us at all times, for all the effort they have made to keep our Centre on the right track. We look forward to the coming year with confidence that the Southern Centre will be as always one of the leading promoters of the 'Sport' of motorcycling.
