

Around the Centre

When the premier trials event in the country - the British Experts - continually falls short on the organisation stakes, it is small wonder that even long established nationals are subject to criticism as to their enjoyment. With the loss of the whole of the forest ground, many critics spouted the death of the Simon trial, but in all honesty the club have turned the event into one of equal enjoyment and a much less early number effort. The limited ground at their disposal was used to its full, probably as a result of having a separate clerk of the course for each area. On the other hand dear old Waterlooville seemed bent on making as little use of their wealth of ground as possible and we were treated to some super knuckle crunching adverse camber, mostly downhill sections that did little to impress the championship contenders for whom the event was intended. The stout tree was always in place to rescue the wrong ride and the lesser enjoyment seemed to stem from those who clouted them hardest. Imagination is, of course, the foremost factor in laying out a course and if after continual rain one does not have an alternative version then there is very little hope for any event, national or otherwise. Not making the Blackmore Vale National this year I was not able to participate in what many have said was too easy a trial, but somehow I gather the whole entry enjoyed it and the number of entries is far more likely to be sustained than the slowly decreasing Hoad - seventy two I believe this year.

The Inter-Centre Team Scramble at Banbury was without doubt the zero of the year. Depending which comic one read first, we as a centre either won it or finished fifth, and though we don't expect them to get it right first time, I feel one could expect at 8p a throw a far closer difference of opinion. Nevertheless the one profitable side of the event that has emerged was the towing out fee operated by the local tractor drivers, but whether the ACU gets any percentage of the gross takings of the operation would seem extremely doubtful. Whether it is best to run under such chaotic conditions or to NO WAY proceedings like this year's Ken Hall event is always a decision hard to take and whatever course is sought there is criticism. Having played a part in destroying many acres of farmland for the Television people I know too well what a shambles ensues, and in most cases the best solution would have been retirement to

the local dart board; at least a firm result would be achieved. To our team must go a hearty pat on the back for an all round honest effort, which almost upset the form book on a par with the glorious '55 win at Rollswood.

By the time I write again another season of good cheer will be past and a few more ulcers set in motion, so perhaps the time is ripe to look back over the year to see how, for instance, Geoff Chandler has progressed in the trials field upon his return to the Ossa concern. It would be more than fair to say that he has become a strong contender at home nationals, not so much a flash in the pan, but a continued effort up and down the country. It has been some time now since a true southerner has been in this position, and it would be nice to see his Simon form maintained in the new year and give the northern riders a run for their money. Anyone who saw the programme on the Scott trial could not help but notice our Geoff if only for being able to translate his speech, the fact that he was more off the bike than on we shall put down to sour grapes by the cameraman. Sammy Miller, too, at the Simon proved that this new machine is going to be competitive and the name Honda is sure to be around the place next year. Nothing would be more in line with the greatest M. Ali, than to see Sam go back to the Highlands and scoop the Scottish just once more thus driving home the nail for good. On the centre front Geoff Guy has emerged as the man to beat, and if progress continues there is no doubt that he will convince us of how good he says he is.

On the racer front it has been Graham Noyce's year without doubt, even if he has swapped machinery just when I said what a good deal he was getting with Don Rickman as his grease monkey (whoops! mechanic I mean). Nevertheless if he can keep clear of injury, then National honours must be on the way. No one has progressed as quickly this past year, and with the established stars reaching the 'veteran' stage, it is normally accepted that a good young 'un eventually will pass by. Let us hope so. Les Lloyd has had a favourable year with the new machines he has had and whilst perhaps not quite as quick as his centre colleague, he has nevertheless emerged from the ruck to the contender stakes at the home championship meetings, so it is fair to expect even better things to come. All the time Lew Coffin continues to trounce the centre Grass Track fraternity then little can be expected of his adversaries. Don't get me wrong, Lew is still a fantastic competitor, but it is twenty years since I first saw him dicing with the Goulds at Corhampton, and surely it is logical to have expected someone to come through the ranks in all that time and put him in at least second place. True, until his accident Bruce Carter showed all the signs and perhaps we can expect the same of Mark Sawyers, possibly the most noteable one with time on his side.

I said last time that I didn't fancy the Jersey trip only for my allergy for water and if reports can be believed my apprehension was well founded! This year Longfellow appointed himself chief fire officer emptying the contents of the hotel fire canisters over, in my absence, Peter Anker, John May and a few others. Nevertheless I understand the Colin Charter Weekend was another rousing beerup coupled with two days of trials riding to fill in the boring daytime hours. In the annals of the Centre Gazette it was recorded at the overnight stop for the 54 Team Trial, which incidentally coincided with November 5th, much diversity was caused in the early hours by our team riders enjoying high spirits. It is nice to know some parts of our sport live on. PJM





Rights of Way Sub-Committee

Only four members of the Rights-of-Way Sub-Committee were present at Treyford on Remembrance Sunday for the now well-established annual meeting.

Proceedings opened at three o'clock with Minutes of the previous meeting, from which there were very few Matters Arising.

The Chairman then gave his report, touching briefly on what he referred to as a temporary victory with regard to restoration of vehicular rights on the U.33 road (on the downs above Kingsclere).

He mentioned the wholesale down-grading of R.U.P.P's to footpath status a situation which had brought horse riders round to the belated realisation that they would have done well to combine forces with motorcyclists in the fight to prevent such action.

Roy Brett's report was concerned largely with the U.33 case, and he confirmed the Chairman's warning that a further traffic closure order would be sought by Hants C.C.

He expressed some anxiety occasioned by reports of a recent motorcycle "green lane run" (along the Berkshire Ridgway) in which the participants had been too numerous, too fast, and too noisy. Some control over T.R.F. activity in our Centre was urged.

Denis Kingswell had nothing to report from his area, and, in the absence of Jeremy May, there was no report from the East. However, the West was well covered by a written report from Ken Broadbery Sayer (with a pat on the back for Wilts C.C. - warmly endorsed by Denis Kingswell) for courteous co-operation.

Brian Palmer gave news from his neck of the woods, with particular reference to the British Horse Society. It was resolved that Ralph Venables should contact a local official of the B.H.S. with a view to collaboration in the fight to maintain rights of way.

Under Any Other Business, the importance of motorcycle representation on local and regional Sports Councils was stressed by Roy Brett, and the awarding of this year's Byways Trophy was discussed (see letter elsewhere in this issue).

Finally, the question of re-electing the members of this Sub-Committee annually - and of adding new members for 1975 - brought our 1974 meeting to a close at six o'clock.


