

#### REPORT ON THE BOARD MEETING HELD ON TUESDAY 12th MARCH 1974 AT THE PORTER BUTT, BATH.

INTER-CENTRE TEAM TRIAL 21st APRIL 1974 nr. BUXTON. This was the same day as the Fourth League Trial but a team would be sent.

WESSEX SCRAMBLE 28th APRIL 1974. The Tor Club reported that they had received 56 entries already. They asked for clubs to supply help on the day.

WESSEX INDIVIDUAL SCRAMBLE CHAMPIONSHIPS. Clubs who were running events were asked to get together and decide whether or not they would donate money to a fund to enable a special cash prize to go with the trophies which the Centre would provide.

Clubs were asked to write to the Secretary with details of their views and amount of support forthcoming.

FEBRUARY GENERAL COUNCIL MEETING. Cliff King had been reelected to the Management Committee. Ken Blampied had received the greatest number of votes of the unsuccessful candidates for the Comps Committee. Compulsory 5p levy — In spite of the A.C.U. Treasurer announcing that he had overestimated the budget by £6000 due to the inclusion of an item for V.A.T. (which would be paid by Clubs and not A.C.U.) the Council had agreed that the levy should be paid. This was carried by a large majority with Wessex Centre and Road Racing Clubs voting against.

HELMETS. The compulsory wearing of helmets off the public roads during Trials was defeated. Wessex had voted for the motion. It was noted that they were compulsory in all Welsh events.

FUEL ECONOMY. Clubs were asked to return the statement forms to the Secretary as soon as possible. League Trials and the Wessex Scramble would be included on the Centre's forms.

T.T. SUPPORTER'S CLUB. The President, Mr.E.Parker, had attended a meeting as the Wessex representative. The Club had more than 800 members but very few in Wessex. He could arrange membership (write to him at 61, Malvern Road, Swindon). Members could take part in many activities in the Isle of Man during the T.T. race period.

GRASS TRACK RACING. Clubs were reminded that all sidecars must be fitted with ignition cut-outs which stopped the engine if the driver left the machine. Also, the clutch must be fully covered, not just the primary chain runs.

The 1974 inter-centre grass-track would be at Bonham Farm, Stourton, Wilts.

SCHOOLBOY SCRAMBLING AND GRASS TRACKS. The A.C.U. were trying to co-ordinate the various organisations but were finding it hard going. The schoolboys were content to stay as they are!

GAZETTE. The Editor reported that he was sending out more opies now than at any time in 1973.

In some cases Clubs were not keeping their regs down to a single page - in future any excess would be charged for.

The Permit Secretary and the Editor complained of the terribly untidy condition of regs. submitted by Clubs. Old copies with a lot of alterations were not satisfactory. If a Club could not type the copy it should be in block letters.

BENEVOLENT FUND LEVY. As agreed at the A.G.M. Clubs must pay 25p for each event. The money to be paid to the Benevolent Fund.

The money should be paid in bulk for all events due to be run after 1st February 1974 and payments should be made immediately to the Permit

Secretary.

LEAGUE TRIAL 21st APRIL 1974. There would be no change in entry fee (50p) — the Centre would pay the 5p levy.

I.S.D.T. AND INTERNATIONAL MOTO-CROSS. Ken Lywood complained of the country's best scramblers probably being chosen to ride in the I.S.D.T. Team to the detriment of the moto-cross teams because of the closeness of the dates. He felt that it was deplorable that this clash had been allowed to occur.

Britains leading trials riders were mostly under contract to foreign manufacturers and preferred to ride in other events rather than the I.S.D.T.

Cliff King said that the A.C.U. should fall into line with certain other countries and introduce a rule prohibiting a rider who declined to ride in his national team from riding in any other international event being run at the same time.

Rod Pillinger, whom we welcome back to the trials ranks after a long lay-off seems to have lost none of his old skills with an award in the league trial and the following week-ends O.T.C. trial to show for his past two rides for about eight years.

With any luck in finding a suitable course, and the relaxation of the emergency restrictions together with the Board approval of a proposed date, another page of this issue should carry the rules, regs and entry forms for our postponed Spring Cup Trial, so please, those gentlemen and lady observers who wish to help a good trial go as it should go, turn the pages to find the date, time and place of start and then present themselves at the first and last, at half an hour before the middle one of the three specified features and the clerk of course will welcome you and the clube thanks you in anticipation.

In the opening round of the three Counties road safety quiz our team and the R.A.C./A.C.U. instructors team were honourably defeated by a very well rehearsed and knowledgeable team of local bus drivers. It was a hard fought battle and the standard of knowledge shown by all the participants was quite remarkable.

Being well aware of the caution enjoined upon contributors to the gazette not to air personal views, I do not hesitate to record the disgust with which a high proportion of the club membership read the proposal being currently canvassed in the Motor-Cycle Press for trials to carry cash awards. It is well recognised that the sport is expensive but, if riders wish to pass up the privileges of amateurism they may well have to face the prospect of finding professional observers, professional Secretaries of Meetings, mechine examiners etc. etc. ad nauseum. Incidentally I am told that the same issue reported a rider and manufacturer's agent at loggerheads in the high court. Is this another sample of what the sport is all about in 1974? If so the days of club life seem to be numbered.

Still on to the lighter evenings and longer days and seeing if things look better in a better light.

#### BRISTOL M.C. & L.C.C.

It would appear that the local soccer match between City and Liverpool together with a clash with the Cotswold Cups caused our Grand Cup Trial to be cancelled.

It would have been worth while if the City had won!

Although the regulations appeared 5 weeks before the scheduled date few people bothered to send in until after the closing date, this consequently forced our decision.

Our Scramble on 21st April however met with a different result and on the first day we had 50 entries, before we had received our Gazette, and by the 3rd day we were full (120) with non-experts and 10 reserves allocated and entries returned into the bargain.

Of course the situation for experts is always different they appear to leave it to the last minute.

On recommendation by members, we have modified the system used for 3 years for the races and introduced a further 2 championship races. With 14 races to get through in an afternoon, I feel it will be all go. Because Angela Cartwright is in the process of becoming a Mum and Mike will have to stand by that week end, unless she gets busy with the "castrol 1R". we shall be looking for people to take their place. Barbara will be unable to manage on her own and so we need help urgently. Our chief marshal is Martin Cox, 16, Chantry Road, Clifton, who will be very pleased to hear from you.

Our car park and pits area has been altered and we hope this new arrangement will be better for both Public and competitors alike. Camping facilities are available for the evening 20th April and a singsong can be arranged in the local, which is walking distance from the course.

I would like to draw readers attention to our team scramble, the regs appeared last month, but should anyone feel that they want a ridel am sure they can be fitted into a team.

If we have a dry day then we propose a full 100 mile event. The Support we received for this event last year prompted us to operate it as a self supporting event.

Our timed trial scheduled for 12th May has been transferred to 15th September because of a clash with Southampton Vikings, and it was felt both events would suffer if held on the same day.

If BSSA members feel they would like to compete on a much modified course, used by the 4 wheeled vehicles, will they please let me know within the next 4 weeks, so I may obtain permission to use the course.

The one exception I believe was Bob Fletcher who must go miles to observe because I've seen him not only in this centre but also in the South Western And Western Centre observing. I understand he has taken the plunge and bought a cotton trials bike, he said it looks so easy when observing that he thought he would have a go, — and the best of luck. I think he would be better off starting in the Southern Centre because just having received their fixture list I notice that throughout the season they run 15 Novice trials plus one for over 40's, and one for under 16's as well as 8 Juniors only scrambles. All these events cater for the up and coming and riders who have just entered the sport which we seem to lack in the Wessex Centre. 
