

REPORT ON THE BOARD MEETING HELD ON 9th DECEMBER, 1975, AT THE PORTER BUTT, BATH

TRIALS RESULTS. Organisers were reminded that they should send copies of the results of all Trials of Restricted to Centre or higher status to the Recorder (P. Smith, 38 Combe Dale, Sea Mills, Bristol) and also include a list giving the best ten performances in order of merit. A form to use would be included with the Permit.

CENTRE DINNER had been enjoyable and the meal good and it was probable that there would be only a small loss.

TRIALS GRADING. Southern, South-West and Wessex Trials Recorders had met for preliminary talks about establishing a common grading scheme. Phil Smith reported that such a scheme would necessitate a registration of drivers as at present used by the Southern Centre and this would probably cost the drivers 10p.

The three Centres agreed on the definition of a Novice.

Phil said that one shortcoming of the present Wessex Grading Scheme was the upgrading of "B" (Intermediate) Drivers as they seldom won a First Class Award. The other Centres included an award for the best Intermediate Driver in their O/C Trials and he recommended that Wessex should do this. A Driver winning the number of these laid down in the Grading Scheme would be upgraded to Expert. He also recommended that downgrading from Expert to Intermediate should occur automatically after a period in which the Driver did not win an Award, probably after one year. This would ensure a more even division of "A", "B" and "C" Classes. There would be no downgrading from "B" to "C".

He asked Clubs to introduce Awards for the Best Intermediate and Best Novice Drivers in their O/C Trials. At present almost all the gradings in Wessex

were based on League Trials only.

Phil Smith said that the Centres wanted to get the new scheme in operation in time for the 1976-77 season, i.e. by September. Delegates were asked to report to their Clubs and the matter would be discussed and voted upon at the Board Meeting on 13th January, 1976.

A.G.M. Clubs were reminded that this was at the Porter Butt, Bath, at 3 p.m. on Saturday, 31st January, 1976.

Delegates requiring tea please inform the Centre Secretary by Tuesday,

27th January, 1976.

The President's Trial went off fairly well, but the Sidecars did take rather a long time negotiating Batch and Chelwood. All the route marking was still up after the event and Ivan took it down. The Route Card was also correct and we would suggest that the Toad read the right line. top half of the entry.

The Time Trial at Row of Ashes, 7th December, was won by Ivan with a loss of 15 marks. Neil Hudson was next best with a loss of 52. In the Scramble Awards Dave Walters and Merv Adams had First Class in the same classification,

and Tony Colman was credited with a First Class along with Pop Plaster, Brian Francis (the first for a long time) and Dave Threadingham. The Novice went to Keith Marsh.




