

REPORT ON THE BOARD MEETING HELD ON TUESDAY, 11th MAY, 1976, AT THE PORTER BUTT, BATH

In order to eliminate delays in clearing accounts, such as occurred in the past due to the absence of one of the officials empowered to sign cheques, arrangements are to be made to permit cheques to be signd by any two of the following: Treasurer, Chairman and Secretary.

WESSEX SCRAMBLE. There had been a good attendance on a cold day and racing had been good, although the programme had been possibly a little too long.

INSURANCE. Quotations had been received from insurers of the premiums necessary to give additional disability payments for injuries sustained in motor cycle sport. These payments were in addition to those provided by the compulsory A.C.U. cover and premiums would have to be mandatory for all Wessex events and range from 40p for each driver in a trial to £1.60 for moto-cross and grass track to give £20 a week benefit.

Details were to be obtained of an insurance scheme which a number of individual drivers had already taken up at very reasonable cost.

STEWARDS' FEES. In view of the rising costs it was decided to increase the fees payable to Centre stewards for the expenses incurred. From 1st June, 1976, they would receive £2.50 for all events, speed and trials.

Trials stewards would be paid by the Centre and the organising club would

pay the steward for speed events.

CHANGES OF DATES. The following were approved: West Wilts Novice and Over Forties Trial (Propaganda Permit) from 12th to 18th September; Bristol M.C. & L.C.C. Trial (C) from 7th to 6th November.

NEW DATE granted for North Somerset for a closed to club trial on 13th June. NORTH GLOUCESTER were granted permission to organise a closed to club road race at Colerne on 22nd August. (It was noted that B.M.C. & L.C.C. had called off the grass track meeting originally planned for that day).

INTER-CENTRE TEAM SCRAMBLE, 3rd October, at Frome. The total prizemoney would be £750 with £200 to the winning team.

THE GREAT RIDGEWAY

The fight to save the Ridgeway is on. After an "experimental" closure in 1975, Oxfordshire County Council have announced their intention of making a permanent closure to vehicles of a section of the Ridgeway near Whitehorse Hill. The section in question is only 2.25 miles long but the implications for motorcyclists are enormous, since not only the Ridgeway itself will be affected but also the many byways which intersect it will be effectively closed.

The County Council give among their reasons for wanting the road closed—the fact that the Ridgeway is now designated as a Long-Distance Footpath and pedestrians are inconvenienced by motor-cycles, the need to preserve the road having regard to its historical significance and the fact that the road is unsuitable for motor traffic. All of these reasons seem to us to be so false as to be beyond argument—but argue we must, and quickly.

Although the area lies within the Southern Centre, this is an issue of great concern to all who value the freedom of motor-cycling. The Swindon Club feel that if this closure is allowed to be made many other counties will use the precedent which will be created to make closure orders on many other byways without having to go through the public enquiry procedure.

We urge everyone who is at all concerned about Rights of Way issues to obtain a copy of the Ridgeway, Prohibition of Driving Order 197 from Oxfordshire C.C. and then make your objections, in writing to the County Secretary before June 14th. Make them as forceful and as factual as you can.

A Public Enquiry will be held at Uffington Village Hall, on 29th June, at 10 a.m., when all objections will be heard. We hope that this will be the occasion of the greatest gathering of motor-cyclists ever seen in Oxfordshire. The B.M.F./A.C.U. Rights of Way Committee are giving their full attention to this, as will many other bodies.

SCRAMBLING IN THE SUNSHINE

Graham Noyce won the Rob Walker Trophy and the Alf Hicken Cup and Rob Taylor had a second in the Rob Walker and a fourth in the Alf Hicken Cup. In the junior races, Ben Ledbury had a win and a second, well done, Ben! We would like to thank everybody who helped to make this event a success.

Some of us went to the Shepton Junior Scramble and spent a very enjoyable day in the sun at North Wootton. Ben Ledbury had a win and seemed set to do well in a later race, but unfortunately his foot-rest fell off which slowed him. Richard Szymanski rode well with a fourth and a second and Martin Perrett with a second place.

On the trials scene our men are doing well, Roger Painter, riding his Suzuki, won the Wilts Border closed to club with a loss of 3 marks, with Bob Williams, Richard Elliott and Stuart Wiggins close behind. The next day we were at Clutton for the Spring Cup Trial which proved very easy for some and very hard for the rest of us, Roger Painter got a fourth best and Bob Williams was fifth. Nice to see Mike Aven in the saddle again after his recent spill. I see Brian Woodhams was also suffering from a badly twisted knee, and had to miss a few trials, but he

came back with a vengeance on Sunday, 9th, at Minety Vale, with a second in the novice trial in the morning and a fifth in the time trial in the afternoon. Robin Strange got a first class award in the novice trial and Richard Elliott was third best in the time trial.

We have been challenged to a skittles match by Shepton crowd later in the summer and the winners will be decided by an aggregate score of the most pins down and most players left standing. Date and venue next month.

So it was a win in only the third meeting on the new bike with more to follow we hope.

The Bristol Motor Cycle and Light Car Club Ltd. will promote a motor-cycle trial for SOLO motor-cycles only and held under a Centre restricted permit on July 11th, 1976. Please note this event is for "A", "B" and "C".

The meeting will be governed by the G.C.R.s of the A.C.U. and the S.S.R.s

of the Wessex Centre applicable to trials, these A.S.R.s and any written instruc-

tions the promoting club may issue for the event.

The event is open to (1) all fully paid up members of the promoting club and (2) members of clubs affiliated to the Wessex Centre, holding current competition licences (which must be shown at the start).

The start and finish will be at the Charterhouse Country Club on B3134, 6 miles east of A38. Map Ref. 172-515 559. Scrutineering starts at 10 a.m. First driver start 11 a.m., others at 1 minute intervals. Any driver not signed on 30 minutes prior to starting time will be deemed a non-starter.

Classes will be as follows (as decreed by Wessex Centre League Trial rules) Class "B"—Intermediate Class "C"—Novice Class "A"—Expert Awards per class subject to the following entries being obtained in that class

10 entries 1st best performance 15 entries 2nd best performance 20 entries 3rd best performance 25 entries 4th best performance

30 entries 5th best performance The maximum number of entries will be 120, e.g. 30 "A", 30 "B" and 60 "C", but vacancies in any class will be allocated to another class. The minimum entry will be 30, less than this the event will not be run.

NOTE—A class will consist of a minimum of 10 entries.


